### **Artwork Minting Policy**

Footballer, www.footballer.com.br, by means of this policy, publicly defines its policy on the **minting of works of art (PMO)** and publicly and globally commits itself to the entire global **NFT** community in terms of compliance with the policy described below.

#### A) General Terms

**1.** This policy applies to All NFT market places where Footballer has active accounts.

- **2.** This policy refers to all works of any kind created by Footballer and published individually or in collections.
- Every work created by Footballer must have a PMO linked to it.

**4.** Each work will have a PMO ID as shown below:

Format: PMO-XXX-YYYY, of which:

**PMO**: Fixed term.

**XXX**: PMO version number located at the bottom of this document.

YYYY: Year of PMO release.

- 5. Each version of the PMO will be published on the Footballer website at www.footballer.com.br .
- 6. This policy defines and adopts the concept of rarity of works (RDO) in order to establish a protection mechanism for buyers and/or resellers of Footballer's works against fraud, crimes, forgeries and scams involving the sale of these works at any time, and also to offer and ensure a reliable and credible pricing mechanism for these same works.
- 7. The rarity of a work defines how rare a work is according to the number of minted copies of this work, on the market place through minting by the author, the Footballer, or through minting by third parties, via DROP, or any other type of minting that may arise

8. The RDO classification will be assigned to a work solely and exclusively by the author, the Footballer, and will follow the table below:

**9.** Throughout its life cycle, a work will only receive one RDO classification and cannot be reclassified. Likewise, a work cannot be re-released individually or in another collection in the future to receive a new RDO. total quantity above refers to the number of times each work is minted.

- 10. A PMO does not affect works published before it, means that a work that is to be published must already belong to a PMO that has already been minted on the market place. This validation is confirmed by the MINT dates of the PMO and the work itself, which are never changed.
- **11.** The RDO classification refers to individual works even if they are part of collections; RDO classification does not apply to entire collections.
- Each work will be identified by its rarity (RDO) as follows:Format: RDO-XX

**RDO**: Fixed term.

**XX**: Identification of the rarity of the work according to the table in eighth item.
